Proof of possession of any license or permit which under federal, state or local laws or regulations, the applicant is required to have in order to conduct the proposed business, or which, under any such law or regulation, would exempt the applicant from the licensing requirements of this ordinance and;

Two (2) photographs of the applicant which shall have been taken within sixty (60) days immediately prior to the date of filing of the application. The photographs shall measure 1 1/2 inches by 1 1/2 inches and show the head and shoulders of the applicant in a clear and distinguishing manner.

A copy of a limited sales tax permit issued by the state of Texas or proof that the goods sold are not subject to such sales tax.

A copy of a current health certificate if merchandise of edible quality is to be sold; provided however, this shall not apply to the sale of candy, nuts, or other edibles prepared and packaged by a nationally recognized manufacturer or a Texas manufacturer meeting standards imposed by state and local health code, if such packages are unbroken.

Have you ever been convicted of a felony, misdemeanor or ordinance violation (other than traffic violations), if you answer yes to this question, on the reverse side this form give the date, location, charge and disposition of any offense.

At the time the application is filed with the City of Hudson Oaks the applicant shall pay a fee to cover the cost to the city of processing the application and investigation the facts stated therein. The application fee shall be ten (\$10.00) dollars for each solicitor or peddler and shall not be refundable.

I understand that I may not solicit/peddle within the city unless I am in possession of a permit, I may solicit/peddle only between the hours of 9:00 a.m. to 9:00 p.m. That I must depart any premises when requested to do so by the occupant, that I may not make any loud or unusual noise to disturb the peace, and that I must display my permit upon request, I further understand that any violation or failure to meet the conditions set forth by city ordinance governing solicitation/peddling may result in denial, suspension or revocation of such permit.

I hereby authorize the City of Hudson Oaks to access any and all information concerning me, my work record, criminal record, and any other record required in determining by qualification for this permit.
