Sign Permit Fees

A. Permanent Signs

This includes a sign on a wall, pole, monument, canopy, marque, pole banner, and electronic price. Each sign should be submitted separately. With each application there is a \$50 application fee.

C. Signs Not Requiring Permit

Window, nameplate, mailbox, real estate, construction, insignia flags, business logo flags, garage sale signs, and an American flag. All signs (including an American flag) must still meet size requirements as called out in the City's Code of Ordinance.

D. Signs Not Allowed in the City

The following signs are prohibited: obscene, searchlights, sign inserts, billboards, living, topographical, projection, flashing, off-premises, sandwich board, moving, electronic message, changeable message, roof, pennant, and portable signs. Also, any signs that are hazardous, nuisance, on a sidewalk/street, or on a tree/utility pole are prohibited, more info can be found in section 3.14.011 in the City's Code of Ordinances.

Based on total square footage of foundation and slab. A \$50 permit application fee will be added to each permit.
